# DOLPHIN (PG) INSTITUTE OF BIOMEDICAL & NATURAL SCIENCES, MANDUWALA, DEHRADUN, UTTARAKHAN

This Memorandum of Understanding (here in after to as MoU) is made on 1.5. The in the year 2023 by and between Shri Guru Ram Rai University, Patel Nagar, Dehradun, Uttarakhand [here in after called SGRRU/first party] and Dolphin (PG) Institute of Biomedical & Natural Sciences, Manduwala, Dehradun, Uttarakhand [second party] on the other part (who for the purpose of MoU are here in after collectively referred to as the parties).

The general objective of this MoU is to stimulate and facilitate the development of collaborative and mutually beneficial programs which serve to enhance the research and training related intellectual life and cultural development on both campuses, and to contribution to increased national and international cooperation. Thus, first party and second party will support of their mutual interests in the field of education and research:

### Article I: Principle of Cooperation

- Joint research Projects
- Dissertation projects for SGRR University students at DIBNS and vice-versa
- Organize joint seminars and conferences
- Joint publications& Patents
- Internships for students
- Access to research laboratories
- Collaborative of research proposals.
- Any other area that both Parties may deem fit from time to time.

### Article II: Areas of cooperation

- Scientists/Staff working in or using Dolphin (PG) Institute of Biomedical & Natural Sciences, Manduwala, Dehradun, Uttarakhand may be enrolled as full time scholars for Ph.D. programs to be awarded by SGRR University. The thesis supervisor will be a regular faculty of SGRR University according to the UGC norms whereas co-supervisor may be from DIBNS per recommendations and approval of Research Advisory Committee (SRC/DRC) of SGRR University
- 2. Research projects on thrust areas like pharmaceutical Chemistry, Microbiology, Chemistry, Biochemistry, Biotechnology, Botany, Zoology, Physics, Agriculture, Forestry and allied sciences can be initiated by the proposed stud cum research Centre with SGRR University faculty may be one of the principal investigator and one co-investigator from each institute, i.e. one from SGRR University or Institute and other from DIBNS
- 3. Ph.D. students working at University may carry out a part of their research work in SGRR University& DIBNS and vice-versa depending upon requirements.
- 4. Award of Academic/Research degree will be governed by UGC norms and regulations and SGRR University Act, Statutes, Regulations and Guidelines .Students/staff and full time scholar working on study cum research center will be allowed to avail a fee concession as per university norms
- 5. Scientists and Faculty of Dolphin (PG) Institute of Biomedical & Natural Sciences may deliver lectures in areas of their specialization to students of SGRR University as Visiting Faculty and vice-versa on days and

- timings pre-arranged on mutual consent. Only TA/Convenience and local hospitality shall be provided by the organizing institute.
- SGRR University Study cum research centers will provide regular short term project training to the students of Dolphin (PG) Institute of Biomedical & Natural Sciences in their areas of specialization and vice –versa.
- 7. Dolphin (PG) Institute of Biomedical & Natural Sciences graduates, postgraduates, Ph.D. students and faculty members may visit the research Centre in the SGRR University for scientific research trainings and demonstrations and vice versa.

# Article III: Duration and Termination of the MoU

- 1. This MoU is effective as of the date of signatures by the Authorities of SGRR University and Dolphin (PG) Institute of Biomedical & Natural Sciences.
- 2. This MoU is valid from the Date of execution by the Parties and shall remain in effect initially for Ten years, and thereafter can be renewed.
- 3. This MoU may be amended at any time by written mutual consent.
- 4. This MoU may be terminated by either party by the provision of written notice of termination not less than one (1) months prior to the desired termination date. However, both parties agree that all continuing obligations to students, staff, funding bodies or other entities are met in full subsequent to the notice of termination.
- 5. The termination of this MoU shall not affect the rights or obligations of either party regarding any binding offer or firm obligation approved and agreed to either party prior to the termination date.
- 6. In event of any dispute/s arising between the parties hereto, it shall be endeavor of both the parties to first make an attempt to resolve the dispute amicably by mutual discussion and deliberation, falling which the dispute shall be referred to Arbitration. The Arbitration shall be conducted as per the provisions of Arbitration and Conciliation Act, 1996 and amendments thereto. The Arbitral Tribunal shall consists of Arbitrator (s), to be appointed mutually by both the parties. The Jurisdiction of Arbitration shall be Dehradun. The language of Arbitration shall be English. The Award of Tribunal shall be final and binding on the both parties.

# Article IV: Miscellaneous

- 1. If any provision of this Memorandum held by any court or other competent authority to be illegal, void or enforceable in whole or in part, this Memorandum shall continue to be valid as to the other provisions therefore and the remainder of the effected provision.
- 2. Nothing in this MoU constitutes or to be construed a party as the partner, agent employee or representative of the other party. A party must not act independently of the other Party and does not have the right or power to commit the other Party on any matter or incur any obligation on behalf of a pledge the credit of the other Party without the prior written approval of the other Party.
- 3. The parties agree to comply with all laws applicable within the jurisdiction of the signatories below.
- 4. Data generated through such collaborative research will be published in scientific.
- 5. Any IPR generated by collaborative research will be shared jointly.

This MoU has been executed into originals, one of which has been retained by the first party and the other by the second party. In witness where of the parties have executed this MoU and represent that they approve, accept and agree to terms contained herein.
