 नहीं करने की कृपा करें।

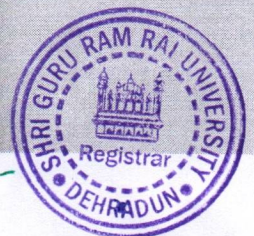


A meeting of University standing committee for SC/ST was convened on 24th April 2023. at 11:30am at Patel Nagar campus, SCR University.


Members of committee attended the meeting. Meeting was chaired by Chairperson, SC/ST Committee.

Chairperson, UGRC welcomed all the Committee members for the meeting and informed the purpose for the same with an aim regarding functioning of UGRC.

Moving ahead, the Chairperson, UGRC brought the various agenda items for discussion.

Post discussion, it was unanimously decided upon the following:-

1. Approved policy and guidelines of UGRC were circulated to all the members of committee.

6. The Member Secretary shall submit the confirmed minutes of the meeting of UGRC to Hon'ble Vice-Chancellor, SGRR University.

5. For this purpose [REDACTED] has submitted a letter mentioning withdrawal of case against [REDACTED]
6. Me and committee members have involved in counseling of mentioned student.








Recommendations


In view of the incident, SC/ST committee has decided to make some recommendations for the awareness among the SC/ST students of SGRR University.
