#### Welcome Address:-

The meeting began with a formal welcome address by the Chairman and the Hon'ble Vice Chancellor, SGRR University. He apprised the House that according to provision of Act the University is empowered to decide its fee structure and can do amendment/rectification from time to time, but it is mandatory to inform the State Govt. about the amendment made in the fee Structure.

He further stated that where the State Govt. fails to take any decision with respect to the approval of Rules within a period as specified i.e. two months from the date of receipt of rule, gives its approval with or without modification.

The Hon'ble Chair informed the house that the IQAC cell has submitted the soft SSR and the management is satisfied with the effort put forth in by the team of IQAC and all the criteria Incharges. He also heartily congratulated the Dean of the School of Agricultural & Sciences about her sincere effort in the development of the Agriculture School. Further, he informed all the members that University is undergoing the recruitment process and till date 15 interviews has been conducted following guidelines of UGC & NAAC and 7 interviews are scheduled in the month of January 2023. He further informed that the recruitment of Faculties in School of Medical & Health Sciences are not being conducted according to

provision of University Statutes despite the direction of Board of Governors of the University. The all round development made by the University in various areas has been enumerated by the Hon'ble Chair before the committee members.

The Chair also informed the house about the various Govt./Non-Govt. research project undertaken by the SGRR University. He Congratulated Dean Research for his efforts in generating the fund of Rs.31 lakhs through the DST (Department of Science & Technology) project and directed all the Deans to motivate faculty members of their schools so that more such research projects can be obtained, this will not only help in generating revenue/aid but at the same time will improve the image of the University globally.

Thereafter, the Hon'ble Vice Chancellor invited Dr. R.P.Singh, Registrar and Member-Secretary of Fee Committee of the SGRR University to conduct the proceedings of the meeting. Initiating the business of the day, the Registrar started the proceedings.

### Agenda -1: Confirmation of Minutes of Sixth Meeting of Fee Committee held on 07<sup>h</sup> September, 2021.

The minutes of the meeting of Fifth Fee Committee of Shri Guru Ram Rau University, held on 07<sup>th</sup> August 2020 have been placed before the house for confirmation. The Chair asked for correction/amendment etc. but no comments were received from the members.

**Resolution:** The house unanimously confirmed the Minutes of the meeting of Sixth Fee Committee held on 07<sup>th</sup> September, 2021. Therefore, it should be treated as confirmed.

## Agenda -2: Action Taken Report on the Minutes of 6th meeting of Fee Committee held on 07th September, 2021.

The action taken report was subjected to scrutiny before the house. The merger of existing heads – Development Fee and Other Fee into a single head – 'Academic Service Charges' was taken up for discussion.

**Resolution:** - The House was informed that at present no University is showing Development and other Fee under a single head (Academic Services Charges). Therefore, it was decided that for the upcoming academic year 2023-2024 the Development Fee and Other Fee will reflect under the same head in the fee structure of the University.

**Resolution:** The members reviewed the Action Taken Report thoroughly and expressed satisfaction and granted confirmation of the minutes of the last Fee Committee held on 07<sup>th</sup> September, 2021.

Agenda -3: Consideration and approval the Fee Structure of New Courses started in Academic Session 2021-22 onwards.

**Resolution:** - The House Unanimously approved the increase in Fee Structure on the recommendation of Deans.

Agenda- 4: To consider and approve the revised Fee Structure of existing courses SGRR University from Academic Session 2022-23 onwards.

**Resolution:** - The increased Fee structure of various courses of respective schools of SGRR University was placed before the house for approval. The House Unanimously approved the increase in Fee Structure for Academic Session 2022-2023 on recommendation of the Dean. (Attached as an annexure 1)

Agenda 5:- To consider the incorporation of Alumni fees of Rs 500 per students at the time of Admission/Awarding of Degree/Final semester Fees.

The House was informed to consider the incorporation of Alumni fees of Rs 500 per student at the time of Admission/Awarding of Degree/Final semester Fees to generate the fund in Alumni Association. It was suggested by the members to charge the amount of Rs. 500 at the time of Awarding Degrees. The University cannot charge the Alumni fees in the first semester taking into consideration numerous factors.

**Resolution:-** After due consideration it was resolved to charge the Alumni fee of Rs. 500 at the time of award of Degree or in the last semester fee of the students.

#### Agenda 6:- Any other items with the permission of Chair.

**Point 6(A)** It was informed by the Dean Research that at present 421 Research Scholars are there in different schools of SGRR University. It was proposed to charge Rs. 1100 from each Research Scholar (Life Time Membership) as an Alumni fee to assist the Alumni Association Fund.

**Resolution:** - Unanimously the house agreed on the above mentioned point and it was decided to circulate the message among the Deans of all the Schools as an office order.

**Point 6(B)** The Hon'ble Chair informed the House that a separate Alumni Association has been created for raising the fund and performing the activities of the Alumni Association and ask Dr. Vipul Jain (President) and Dr. Parul Goel (Vice-President) about the present status of the fund raised by the Alumni Association of SGRR University.

**Resolution:-** Dr. Vipul Jain informed the house that a total of Rs. 879000 has been raised in Alumni Association Account so far. Details of contribution are as under:-

- 1- Medical College Approx Rs 590000
- 2- Nursing College Approx 68800
- 3- School of Management & Commerce Studies Approx 72000
- 4- Transfer from the previous Alumni Association 94000



#### 5- Collection from Schools of SGRR University – 54200

Hon'ble Chair directed to Dr. Vipul Jain (President) & Dr. Parul Goel (Vice- President) Alumni Association to put up more sincere efforts and raise the fund to approx Rs.1500000 by the end of January 2023 as expected by the management.

**Point 6(C):-** The members have requested that the Medical Services and Guest House facilities can be provided our Alumni and a proposal can be sent to the Hon'ble Chancellor sir for consideration and approval.

**Resolution:** - The entire member present in the house accepted the suggestion and decided to send the proposal to the Hon'ble Chancellor Sir for approval.
