- 5. Actively participate in running the Coaching and Guidance Centre, National Social Service Scheme, Employment Bureau, General Education Centre, and other co-curricular activities, in consultation with the respective heads.
- 6. Coordinate and arrange the disbursement of financial aids, scholarships, stipends, etc., to students.
- 7. Make arrangements with Railway authorities for the issuance of railway concessions to students during vacations for educational tours and extracurricular activities.
- Issue character certificates for students based on reports from the Provosts, Dean of Faculty, and Proctor.
- Work for the welfare of students as per the Regulations and any additional instructions from the Vice-Chancellor.
