Welcome Address:-

In his introductory address, the Chair extended hearty welcome to all members present inside the hall as well as External members who were available added that their knowledge, views and experience in their respective fields will be beneficial for the progress of the University. The

Chair welcomes the external member J.P Pauchari & Prof Dinesh Singh. The chair also asked all the members to give their brief introduction. The chair told the house about the remarkable admission which took place in our university i.e. approx. 3000. The chair also told that the SMIH (Shri Mahent Inderesh Hospital) got the 1st position in Uttarakhand and 18th position in north India. The Chair informed the Hon'ble Chancellor about the degree of D.lit by Doon University on 14/12/2021. In the course of language very good admissions were their in School of Humanities & Social Sciences. Some diploma courses and some skill development courses will also be started by our university during academic session 2022-2023.

The University also completed orientation programme for our students. The university also conducted the annual sports and cultural week so that the students are given an opportunity to show cast their extra curriculum skill. The university is also planning for the application with UGC to get the status of 12B for various resource activities.
